Terms & Conditions

1. NAME _____
The Club shall be called Green Trekkerz (hereinafter called "the Club")
2. MANAGEMENT
 - 2.1 Green Trekkerz, a club incorporated in Malaysia and having its management office at j.hong, Bandar Sri Damansara, 52100 Kuala Lumpur (hereinafter called "the Club") is the owner and shall have the sole and exclusive right to administer, operate, manage and control the Club and its activities and operations and do all such acts and things as are necessary conducive incidental or ancillary to maintain the Club.
 - 2.2 The Club shall have the discretion to determine from time to time the nature and scope of the activities at the Club (hereinafter referred to as "the Activities") which shall be available for Members and regulate the terms and conditions in respect of such utilisation.
3. MEMBERSHIP
 - 3.1 Admission to membership of the Club shall be by application in writing signed by the Applicant. Such application shall be in such form as the Club shall from time to time prescribe.
 - 3.2 The Club shall have the discretion to approve or reject the application by an Applicant to be a Member of the Club without assigning any reasons whatsoever.
 - 3.3 The number of Members shall be limited to such number, as the Club shall, at its absolute discretion deem fit.
 - 3.4 The Club membership shall not be transferable.
 - 3.5 Members shall be required to produce identification or membership cards to the Club before joining the Activities.
4. CLASS OF MEMBERS
 - 4.1 Subject to such other additional classes of Members as the Club may create from time to time upon such terms and conditions as the Club shall determine there shall be the following classes of Members:-
 - a. Individual Members
 - i. Individual Members shall consist of persons who are not less than eighteen (18) years of age.
 - ii. Individual Members shall have the right to enjoy the Activities provided or maintained by the Club subject to the payment of the Projected Cost as shall be determined by the Club from time to time and all other dues and charges and performing the covenants and stipulations herein and abiding by the Rules and Regulations of the Club.
5. TERM
 - 5.1 Subject to the provisions of Clause 8 herein, the Member shall be entitled to use and enjoy the Facilities provided by the Club for a period of up to a maximum of 364 days from the date of payment by the Applicant of the Membership Fee (hereinafter referred to as "the Term") provided always that nothing shall grant or be implied to grant to the Member any legal, equitable or proprietary right titles, interests, estates or shares in the Club and/or the Company or its assets or properties or any part thereof.
 - 5.2 Upon the expiry of the Term of the membership, the Member shall have the option to renew the membership for such period and upon such terms and conditions as may be determined by the Club at its absolute discretion from time to time provided always that the Member shall not have breach any of the rules, regulations, terms and conditions of the Club during the term of the membership.
6. DRESS CODE
 - 6.1 Members are required to dress in attire suitable for the activities subject to supervision by GTzC Personnel.
7. PROJECT COSTING
 - 7.1 A statement of account per trip and all other charges incurred by the participant shall be compiled.
 - 7.2 The projected cost shall become due and payable on the final day of the trip in which the participant's application to be admitted as Member was approved unless otherwise determined by the Club at its absolute discretion. Thereafter the Projected cost shall become due and payable on the final day of every trip.
 - 7.4 Any Individual Participant who intends to be absent for a particular trip must inform the organiser where upon the Club shall at its absolute discretion determine the amount of the Projected Cost as shall be payable by the Participant or alternatively waive payment of the Projected Cost upon such terms and conditions as the Club shall deem fit.
 - 7.5 The Club shall have the absolute discretion to vary the Projected Cost from time to time by giving the Participant 3 days' notice.
8. CESSATION OF PARTICIPATION
 - 8.1 A Participant shall cease to be a Participant of the Trip in any of the following events:-
 - i) If the Participant fails to pay their Projected Cost, the Club is entitled to suspend the participation.
- 9.0 PROHIBITION
 - 9.1 The use of any DRUGS, alcohol, dangerous weapons or such other illegal items as may determined by the Club from time to time, shall be forbidden in the Club's activities.
 - 9.2 Participants shall not do or cause any damage to the Club or any part there of or any other property belonging to the Club.
 - 9.3 Participants shall not litter deface or in any way create any nuisance whilst on the trip of the Club and/or Activities.
 - 9.4 No livestock, animals or household pets shall be allowed to bring back during any trips and/or activities.
 - 9.5 All rubbish are to be disposed in rubbish bins or recycling bins. No one is allowed to bring back any form of dead or living items from the sea or forest. All your cooperation will be very well appreciated in order to protect and preserve the wonderful greens of our country.
 - 9.6 Anyone found possessing or consuming any form of drugs will be fined RM300
- 10.0 REGULATIONS

The Company shall have the power at its absolute discretion to make and implement from time to time further or additional regulations to govern the use, operation and enjoyment of the Club, its Activities or any part thereof and to regulate the rights privileges, obligations and duties of the Participants (hereinafter referred to as "the Regulations"). The Regulations may, amongst other things, prescribe the Participation Fee, and projected cost payable by the Participant and/or restrict or confer such other rights and privileges of the Participant as the Club shall at its absolute discretion deem fit. The Club may at its absolute discretion at any time and from time to time with prior notice to the Participants make and enforce such further or amended Regulations by supplementing, revising and/or amending the Regulations as the Club deems fit.
- 11.0 CHANGE OF RULES, TERMS AND CONDITIONS

The Rules, terms and conditions contained herein may be amended, substituted or varied at any time and from time to time by the Club at its absolute discretion by giving notice to the Participants.
